



Official Rules for fb.com/BigTexasSpring, fb.com/BigTexasClearLake, fb.com/DJGaryBigTexas, or fb.com/DJEricBigTexas Giveaways on Facebook

By participating in a Facebook (all references to fb.com are short for facebook.com) Giveaway (a "Promotion") promoted by fb.com/BigTexasSpring, fb.com/BigTexasClearLake, fb.com/DJGaryBigTexas, or fb.com/DJEricBigTexas (each such Facebook account, a "Business Account") , you agree to these Official Rules, which are a contract, so read them carefully before participating. Without limitation, this contract includes indemnities to the released parties from you and a limitation of your rights and remedies. The contract will refer to you as "you" or "Participant".

These promotions are in no way sponsored, endorsed or administered by , or associated with Facebook. Facebook is released of any and all liability to the administrators and the participants in any contests or giveaways.

The details and requirements for entry or participation in any Promotion shall be provided by the Business Account from time to time, in the discretion of the Business Account. Participants must follow the directions provided by the Business Account and otherwise be bound by and follow these Official Rules to be eligible to receive a prize in connection with any Promotion.

You must be at least 21 years of age to participate in a Promotion. A Participant must have a valid, Facebook account and be a follower of the applicable Business Account announcing the Promotion to be eligible to participate. Employees, officers, directors, representatives and agents of any Big Texas entity (listed below) and each of their respective parents, subsidiaries & affiliated companies and their immediate families and those living in their same household, whether or not related, are not eligible for any Promotion. The Business Account will determine giveaway recipients in its sole and absolute discretion, subject to verification of eligibility, receipt of a qualified entry and compliance with these Official Rules and the instructions provided by the Business Account. The time of receipt of any valid entry shall be the time such valid entry becomes available to the Business Account on Facebook.com. The Business Account's computer shall be the official clock of the Promotion. Limit one (1) entry per person and per Facebook account per Promotion. If you have received a prize in connection with a Promotion in the last 30 days, you're not eligible.

TRANSPORTATION TO/FROM VENUE OR ANY OTHER LOCATION, AND ANY LODGING, PARKING, GRATUITIES OR ANY EXPENSES NOT SPECIFIED BY THE BUSINESS ACCOUNT ARE NOT INCLUDED IN ANY PRIZE. Participants may not take actions that are negligent, injurious or reckless in pursuit of any prize offered in connection with a Promotion. Participants are solely responsible for any injuries or other damages that are caused from their behavior. The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of participants or the Released Parties in connection with the Promotion will be governed by and construed in accordance with the internal laws of the State of Texas, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other state's laws.

BY PARTICIPATING IN A PROMOTION, EACH PARTICIPANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (1) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE PROMOTION, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (2) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED FIFTY DOLLARS (\$50.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (3) UNDER NO CIRCUMSTANCES WILL ANY PARTICIPANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND PARTICIPANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED FIFTY DOLLARS (\$50.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (4) PARTICIPANT'S

REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND PARTICIPANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Participants agree to waive any rights to claim ambiguity of these Official Rules. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Promotion-related materials, privacy policy or terms of use on an applicable website and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Big Texas's sole and absolute discretion. Business Account reserves the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Promotion. In the event that the Promotion is challenged by any legal or regulatory authority, Business Account reserves the right to discontinue or modify the Promotion, or to disqualify participants residing in the affected geographic areas. In such event, the Released Parties shall have no liability to any participants who are disqualified due to such an action.
